# YP PUPPY RESCUE

## Adoption Agreement

### Adoption Agreement

The Animal will be rehomed to you on a trial period (if applicable) as listed above and can be returned to YP Puppy Rescue during that period if the Animal is deemed unsuitable. You understand that a member of YP Puppy Rescue may inspect your premises to ensure the Animal will be housed in safe and secure surroundings pre-adoption and may visit during the trial period.

You agree to contact YPPR immediately should any problems arise during the trial period (if applicable), this includes the Animal becoming lost or if you have any health or behavioral concerns. If the Animal requires medical attention during the trial period (if applicable) you agree to contact YPPR, immediately. Any veterinary costs incurred by you will not be refunded unless the Animal is treated by our nominated veterinary practice and prior approval from YPPR has been given for said treatment.

If at any time during or after the trial period as listed above, YP Puppy Rescue becomes aware that the Animal is being mistreated or is deemed to be at risk, YP Puppy Rescue may seize that Animal without notice. The Animal will only be returned to the adopter after YP Puppy Rescue considers the situation resolved and the Animal faces no further threat. If YP Puppy Rescue feels the situation cannot be resolved, then they may list the Animal for rehoming, and you will receive no moneys or refunds.

By signing this contract, and at the completion of the trial period as listed above, you are agreeing to the following:

- You agree to maintain and house the Animal under the conditions of the South Australian State Act governing the care of companion animals and meet all council bylaws.
- You understand that it is your responsibility to register the Dog in your name at your local Council and are responsible for any cost or charges incurred should the Dog be impounded.
- You always agree to keep this Animals microchip and ID details updated and correct.
- You agree to provide all regular veterinarian treatment, including vaccinations, parasite control and immediate treatment of any illness or injury.
- You agree to seek professional advice from a registered behavioral trainer if this animal develops any serious behavioral issues.
- You agree to adopt the Animal and will consider the Animal to be part of the family and, as such, be welcomed into the family home and sleep inside the home or in an enclosed, safe, protected area at night.
- You agree that if at any point during the Dog's life you are no longer able to care for the Dog, you must contact YP Puppy Rescue immediately.
- You will take responsibility for any damage or injury caused by the Animal during the trial period. Should damage or injury occur it is recommended that the Animal be returned to YP Puppy Rescue as soon as possible. After the trial period as listed above, you will be legally responsible for the Animal under State and Federal Laws.
- You agree and understand that when the Dog is adopted by you it will be micro chipped, desexed, vaccinated, and treated for worms, and fleas. (Should alternate desexing arrangements be made with YP Puppy Rescue we require a copy of the Desexing Certificate along with relevant vaccination records within the period stated on the De Sexing agreement.)
- You understand that YP Puppy Rescue cannot be held responsible for the Animal should it suffer ill health and/or develop an unsatisfactory temperament.
